ORDINANCE NO. 09 – 02

AN ORDINANCE AMENDING TITLE 2 ("ADMINISTRATION AND PERSONNEL"), CHAPTER 2.12 ("BOARD OF TRUSTEES"), SECTION 2.12.060 ("MEETINGS OPEN TO THE PUBLIC") OF THE HARWOOD HEIGHTS VILLAGE CODE REGARDING THE INCLUSION OF COMMITTEE OF THE WHOLE.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HARWOOD HEIGHTS, IN THE EXERCISE OF THEIR HOME RULE POWERS, AS FOLLOWS:

SECTION 1. Village Code Amended. Title 2 ("Administration and Personnel"), Chapter 2.12 ("Board of Trustees"), Section 2.12.060 ("Meetings Open to the Public") is hereby amended by adding the underlined language to read as follows:

2.12.060 Meetings open to the public.

All regular, Committee of the Whole or special meetings of the village board shall be open to the public, except that the board may discuss a subject in executive session as provided by law. (Prior code § 31.16)

SECTION 2. Severability and Repeal of Inconsistent Ordinances. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 3. Effective Date. This ordinance shall be in full force and effect immediately after its passage and publication as required by law.


