ORDINANCE NO. 09 – 03

AN ORDINANCE AMENDING TITLE 2 ("ADMINISTRATION AND PERSONNEL"), CHAPTER 2.12 ("BOARD OF TRUSTEES"), SECTION 2.12.180 ("COMMITTEE OF THE WHOLE") OF THE HARWOOD HEIGHTS VILLAGE CODE REGARDING THE SCHEDULING, MINUTES AND VOTING AT SUCH MEETINGS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HARWOOD HEIGHTS, IN THE EXERCISE OF THEIR HOME RULE POWERS, AS FOLLOWS:

**SECTION 1. Village Code Amended.** Title 2 ("Administration and Personnel"), Chapter 2.12 ("Board of Trustees"), Section 2.12.180 ("Committee of the Whole") is hereby amended by adding the underlined language and deleting the stricken language to read as follows:

**2.12.180 Committee of the whole**

The mayor and board of trustees shall hold Committee of the Whole meetings on the first Wednesday of each month at seven p.m. Additional meetings of the Committee of the Whole prior may be called by the mayor or three trustees when deemed necessary. When the board meets as a *committee* of the whole, without objection, the president shall continue to serve, otherwise the board shall appoint a chairperson to preside, and the presiding officer of the board shall leave the chair. The rules of the board as far as applicable shall be observed in the *committee* of the whole, except that no limit shall be placed on the frequency of speaking. ~~and that the yeas and nays shall not be taken.~~ Minutes of the Committee of the Whole should be approved within a reasonable time after the meeting and are to be included on the agenda for approval at the next Committee of the Whole meeting. (Prior code § 31.50)

**SECTION 2. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION 3. Effective Date.** This ordinance shall be in full force and effect immediately after its passage and publication as required by law.


