ORDINANCE NO. 10-32

AN ORDINANCE ABATING THE TAX HERETOFORE LEVIED FOR THE YEAR 2010 TO PAY THE INTEREST AND PRINCIPAL ON \$490,000 GENERAL OBLIGATION BONDS, SERIES 2006A OF THE VILLAGE OF HARWOOD HEIGHTS, COOK COUNTY, ILLINOIS

WHEREAS, the President and Board of Trustees (the "Board") of the Village of Harwood Heights, Cook County, Illinois (the "Village"), by ordinance 06-15 adopted on the 27<sup>th</sup> day of April, 2006 (the "Ordinance"), did provide for the issuance of \$490,000 General Obligation Bonds, Series 2006A and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bond; and

WHEREAS, the Village will have deposited adequate funds to the 2006 Debt Service Fund (as defined in Section 13 of the Ordinance) for the purpose of paying interest and principal on the Bond up to and including December 1, 2011; and

WHEREAS, it is necessary and in the best interest of the Village that the tax levied for tax levy year 2010 be abated in its entirety.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HARWOOD HEIGHTS, COOK COUNTY, ILLINOIS AS FOLLOWS:**

**SECTION 1: *Abatement of Tax.*** The tax heretofore levied for the year 2010 in the Ordinance is abated in its entirety

**SECTION 2: *Filing Certificate.*** Forthwith upon the adoption of this Ordinance, the Village Clerk shall file a certified copy hereof with the County Clerk of Cook County, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2010 in accordance with the provisions hereof.

**SECTION 3:** In the event that any provision or provisions, or portion or portions of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, remaining provisions or portions of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions.

**SECTION 4:** That all ordinances or parts thereof in conflict with the terms of this Ordinance are hereby repealed and of no further force and effect to the extent of any such conflict.

**SECTION 5:** That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

**SECTION 6:** That this Ordinance shall be in full force and effect from the date of its passage, approval and publication in pamphlet form as provided by law.




