

**ORDINANCE NO. 19-05**

**AN ORDINANCE AMENDING THE DUTIES OF THE POLICE AND SAFETY  
COMMITTEE (2.12.260 (C)) AND ESTABLISHING THE DUTIES OF THE PUBLIC  
HEALTH COMMITTEE (2.12.260(M)) OF THE HARWOOD HEIGHTS  
CODE OF ORDINANCES**

**WHEREAS**, the Village of Harwood Heights (the "Village") is an Illinois municipal corporation organized and operating pursuant to authority granted by the Constitution and Laws of the State of Illinois;

**WHEREAS**, the Village is a home rule unit of government pursuant to Section 6(a), Article VII of the 1970 Illinois Constitution; and

**WHEREAS**, pursuant to its home rule power, the Village may exercise any power and perform any function relating to its government and affairs; and

**WHEREAS**, the Corporate Authorities have established various committees to assess and recommend measure for the improvement and progress of the Village Board;

**WHEREAS**, the Corporate Authorities have found an increased need for a separate Public Health committee and a need to eliminate redundancy with a separate Building committee;

**WHEREAS**, the Corporate Authorities desire to amend certain provisions of Chapter 2.12.260 (C) and 2.12.260 (M) to reflect the duties of the Police and Safety committee and the Public Health committee and delete 2.12.260(J) in its entirety;

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Harwood Heights, County of Cook, Illinois, as follows:

SECTION I. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1. Additions are indicated by **bolded and underlined font** whereas deletions are ~~struck through~~

SECTION 2. Amendments to Chapter 2.12.260(C) Police, Safety and Public Health

- C. ~~Police, Safety and Public Health.~~ **Police and Safety.** The committee will report to the corporate authorities regarding the operations and effectiveness of the police department. The committee will work closely with the chief of police, the mayor, and the board of police commissioners. The committee shall make recommendations to the corporate authorities regarding the operations of the police department, compensation, and equipment needed to carry out police services. The committee shall endeavor to work with police committees in other communities in an effort to coordinate efficient police services in the areas surrounding the village.

~~The public health and safety committee shall report to the corporate authorities regarding environmental conditions within the village. The committee shall receive reports from the health inspectors regarding their duties in the community and review inspectors' responses to inquiries and complaints regarding potential or actual health hazards. The committee will work closely with county and state officials to guarantee to the citizens of the village a healthy and safe environment and explore and recommend programs of public education.~~

SECTION 3. Delete Chapter 2.12.260(J) Building Committee.

SECTION 4. Amendments to Chapter 2.12.260(N) Public Health

**N. Public Health. The public health and safety committee shall report to the corporate authorities regarding environmental conditions within the village. The committee shall receive reports from the health inspectors regarding their duties in the community and review inspectors' responses to inquiries and complaints regarding potential or actual health hazards. The committee will work closely with county and state officials to guarantee to the citizens of the village a healthy and safe environment and explore and recommend programs of public education.**

SECTION 5. RESOLUTION OF CONFLICTS.

All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6. SAVING CLAUSE.

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

SECTION 7. EFFECTIVE DATE.

This Ordinance shall be in full force and effect from and after May 23, 2019.




