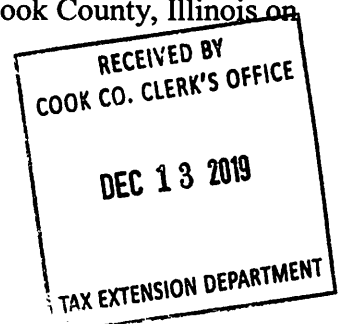

ORDINANCE NO. 19 - 23

**AN ORDINANCE ABATING THE TAX HERETOFORE LEVIED FOR THE TAX
LEVY YEAR 2019 TO PAY THE INTEREST AND PRINCIPAL ON \$2,500,000
GENERAL OBLIGATION BONDS, SERIES 2017 OF THE VILLAGE OF HARWOOD
HEIGHTS, COOK COUNTY, ILLINOIS**

WHEREAS, the President and Board of Trustees (the “Village Board”) of the Village of Harwood Heights (“the Village”) is a home rule unit of government pursuant to Section 6(a), Article VII of the 1970 Illinois Constitution; and

WHEREAS, the Village, as a home rule unit of government, may exercise any power and perform any function pertaining to its government affairs; and

WHEREAS, the Village Board, by Ordinance 17-02 adopted on the 9th day of February, 2017 (the "Bond Ordinance"), did provide for the issuance of \$2,500,000 General Obligation Bonds, Series 2017 (the “Bonds”) and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS, on the 13th day of October, 2017, a duly certified copy of the Bond Ordinance and a corresponding bond order and certificate of the levy of taxes pursuant to the Bond Ordinance (the “Bond Order”) were filed in the office of the Cook County Clerk; and

WHEREAS, the Village will have deposited adequate funds into the “Bond Fund” (as defined in the Bond Ordinance) on or prior to March 1, 2020 for the purpose of paying the principal and interest on the Bonds coming due on June 1, 2020 and December 1, 2020 (cumulatively, the “2020 Debt Service”); and

WHEREAS, the Village hereby directs the deposit of funds into the Bond Fund in an

amount equal to the 2020 Debt Service for the purpose of paying principal and interest on the Bonds up to and including December 1, 2020; and

WHEREAS, it is necessary and in the best interest of the Village that the tax levied for tax levy year 2019 in the Bond Ordinance and accompanying Bond Order be abated in its entirety.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Harwood Heights, County of Cook, Illinois, in the exercise of the Village's home rule powers, as follows:

SECTION 1. RECITALS.

That the foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

SECTION 2. ABATEMENT OF TAX.

The tax heretofore levied for the tax levy year 2019 in the Bond Ordinance and in the accompanying Bond Order is abated in its entirety.

SECTION 3. FILING CERTIFICATE.

Forthwith upon the adoption of this Ordinance, the Village Clerk shall file a certified copy hereof with the County Clerk of Cook County, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the tax levy year 2019 in accordance with the provisions hereof.

SECTION 4. RESOLUTION OF CONFLICTS.

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5. SAVING CLAUSE.

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

SECTION 6. EFFECTIVENESS.

This Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.

SECTION 7. PUBLICATION.

The Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 8. EFFECTIVE DATE.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
