# AN ORDINANCE AMENDING THE AWARD OF GARBAGE COLLECTION CONTRACTS IN CHAPTER 8.16.020 AUTHORITY FOR PRIVATE CONTRACTS OF THE HARWOOD HEIGHTS CODE OF ORDINANCES

WHEREAS, the Village of Harwood Heights (the "Village") is an Illinois municipal corporation organized and operating pursuant to authority granted by the Constitution and Laws of the State of Illinois;

WHEREAS, the Village is a home rule unit of government pursuant to Section 6(a), Article VII of the 1970 Illinois Constitution; and

WHEREAS, pursuant to its home rule power, the Village may exercise any power and perform any function relating to its government and affairs; and

WHEREAS, the Corporate Authorities have established various committees to assess and recommend measure for the improvement and progress of the Village Board;

WHEREAS, the Corporate Authorities have found it necessary to allow condominium associations and their respective boards to enter into contract agreements with garbage and rubbish collectors of their choice,

WHEREAS, the Corporate Authorities desire to amend certain provisions of Chapter 8.16.020 to eliminate the requirement that condominiums contract with the garbage and rubbish collector selected by the Corporate Authorities for residential properties located in the Village;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Harwood Heights, County of Cook, Illinois, as follows:

SECTION I. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1. Additions are indicated by **bolded and underlined font** whereas deletions are **bolded and struck through**.

SECTION 2. Amendments to Chapter 8.16.020 Authority for private contracts

#### 8.16.020 - Authority for private contracts.

The village will contract with a private scavenger for the collection of garbage and rubbish for all residential properties, including **condominiums**, for **multi-family** buildings **which** that have no more than three dwelling units.

#### SECTION 3. RESOLUTION OF CONFLICTS.

All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

#### **SECTION 4. SAVING CLAUSE.**

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

## **SECTION 5. EFFECTIVE DATE.**

This Ordinance shall be in full force and effect from and after January 14, 2021.
