ORDINANCE NO. 21-04

AN ORDINANCE AMENDING CHAPTER 2.92.010 PUBLIC RECORDS: REQUESTS TO BE IN WRITING AND CHAPTER 2.92.040 INSPECTION OF RECORDS OF THE HARWOOD HEIGHTS CODE OF ORDINANCES

WHEREAS, the Village of Harwood Heights (the "Village") is an Illinois municipal corporation organized and operating pursuant to authority granted by the Constitution and Laws of the State of Illinois:

WHEREAS, the Village is a home rule unit of government pursuant to Section 6(a), Article VII of the 1970 Illinois Constitution; and

WHEREAS, pursuant to its home rule power, the Village may exercise any power and perform any function relating to its government and affairs; and

WHEREAS, the Corporate Authorities have established various committees to assess and recommend measure for the improvement and progress of the Village Board;

WHEREAS, the Corporate Authorities have found it necessary to amend the village code to reflect the correct address of the Harwood Heights Village Hall, the operating hours of that facility and the identification of the Freedom of Information form (FOIA);

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Harwood Heights, County of Cook, Illinois, as follows:

SECTION I. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1. Additions are indicated by **bolded and underlined font** whereas deletions are **bolded and struck through.**

SECTION 2. Amendments to Chapter 2.92.010 Requests to be in writing.

2.92.010 - Requests to be in writing.

All requests for production, copying, inspection or certification of public records shall be made in writing in substantially the form designated as Form No. 1984-1-A which is incorporated herein by reference and which is on file and available upon request at Village Hall by completing a Freedom of Information Act (FOIA) form. The form is available on line or upon request at the Village Hall. All such requests must be signed by the person making the request. No unsigned requests will be processed.

SECTION 3. Amendments to Chapter 2.92.040 Inspection of records

2.92.040 - Inspection of records.

- A. All records may be inspected at the Village Hall located at 7343 West Lawrence Avenue 7300 West Wilson Avenue, Harwood Heights, Illinois, during normal business hours which are Monday, Tuesday, Thursday and Friday Monday through Friday, nine a.m. to five p.m. and Saturday, nine a.m. until one p.m. No records may be removed from the office at any time.
- B. With respect to employee personnel records, inspections may take place before or after normal business hours if the employee so requests.

SECTION 4. RESOLUTION OF CONFLICTS.

All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5. SAVING CLAUSE.

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

SECTION 6. EFFECTIVE DATE.

This Ordinance shall be in full force and effect from and after January 14, 2021.
