ORDINANCE NO. 22-05

**AN ORDINANCE AMENDING THE GARBAGE FEE IN CHAPTER
8.16.024 OF THE HARWOOD HEIGHTS CODE OF ORDINANCES**

WHEREAS, the Village of Harwood Heights (the "Village") is an Illinois municipal corporation organized and operating pursuant to authority granted by the Constitution and Laws of the State of Illinois;

WHEREAS, the Village is a home rule unit of government pursuant to Section 6(a), Article VII of the 1970 Illinois Constitution; and

WHEREAS, pursuant to its home rule power, the Village may exercise any power and perform any function relating to its government and affairs; and

WHEREAS, the Corporate Authorities have established various committees to assess and recommend measure for the improvement and progress of the Village Board;

WHEREAS, the Corporate Authorities have found it necessary to increase garbage fees to address the rising costs of refuse collection;

WHEREAS, the Corporate Authorities desire to amend certain provisions of Chapter 8.16.024 to implement a nominal increase in the senior citizen garbage fee for residential properties located in the Village;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Harwood Heights, County of Cook, Illinois, as follows:

SECTION 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

SECTION 2. Amendments to Chapter 8.16.024 Garbage Fee

8.16.024 - Garbage fee.

A. Single Family Unit (Bimonthly Billing).

1. The garbage fee per single-family unit is a twenty-seven dollar and 50 cent (\$27.50) bimonthly charge except as provided in subsection (A)(2).
2. The garbage fee for senior citizens (defined as those persons 65 years of age or older) shall be a bimonthly charge of nineteen dollars and 50 cents (\$19.50). Only those senior citizens owning and residing in a single-family residence are eligible to apply for the rate under this subsection.

B. Two-Family Units or Multiple Family Units (Monthly Billing).

1. The garbage fee per multiple family unit (two flats) is a twenty-seven dollar and 50 cent (\$27.50) monthly charge.

C. Three-Family Units or Multiple Family Units (Monthly Billing).

1. The garbage fee per multiple family unit (three flats) is a thirty dollar (\$30.00) monthly charge.

SECTION 3. RESOLUTION OF CONFLICTS.

All ordinances in conflict herewith are hereby repealed to the extent of such conflict.


SECTION 4. SAVING CLAUSE.

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

SECTION 5. EFFECTIVE DATE.

This Ordinance shall be in full force and effect from and after June 1,
2022.
