#### **ORDINANCE NO. 23-02**

AN ORDINANCE AMENDING TITLE 8 (HEALTH AND SAFETY) OF THE VILLAGE OF HARWOOD HEIGHTS CODE OF ORDINANCES TO DESIGNATE UNATTENDED CHILDREN AND ANIMALS IN VEHICLES AS A NUISANCE AND IMPOSE PENALTIES

WHEREAS, the Village of Harwood Heights (the "Village") is an Illinois municipal corporation organized and operating pursuant to authority granted by the Constitution and Laws of the State of Illinois;

WHEREAS, the Village is a home rule unit of government pursuant to Section 6(a), Article VII of the 1970 Illinois Constitution;

WHEREAS, pursuant to its home rule power, the Village may exercise any power and perform any function relating to its government and affairs;

WHEREAS, the Village is authorized to define, prevent, and abate nuisances (65 ILCS 5/11-60-2);

WHEREAS, the Village is further authorized to prohibit cruelty to animals (65 ILCS 5/11-60-2);

WHEREAS, State law prohibits endangering the life or health of a child, including leaving children unattended in a motor vehicle for 10 or more minutes (720 ILCS 5/12C-5(a); 720 ILCS 5/12C-5(b); 720 ILCS 5/12C-5(c));

WHEREAS, State law further prohibits the cruel treatment of animals, including confining animals in motor vehicles in such a manner that places the animal in life or health threatening situations (510 ILCS 70/3(a); 510 ILCS 70/3.01(a); 510 ILCS 70/3.01(c); 510 ILCS 70/7.1);

WHEREAS, the corporate authorities desire to amend the Village Code of Ordinance to

prohibit and declare unattended children and animals in motor vehicles a public nuisance within the Village;

WHEREAS, to protect the public health, safety, and welfare, the Village of Harwood Heights has a clear and compelling interest in exercising its home rule authority as set forth herein.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Harwood Heights, County of Cook, Illinois, in the exercise of the Village's home rule powers, that the Village Code be amended as follows, with all existing provisions of the Village Code not set forth below continuing in full effect as currently written:

**SECTION 1. RECITALS.** The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

<u>SECTION 2.</u> <u>AMENDMENT.</u> Title 8 ("Health and Safety") of the Village of Harwood Heights Code of Ordinances, shall be, and hereby is amended to add Chapter 8.36 ("Unattended Children in Motor Vehicles") as follows: (additions in <u>bold and underline</u>):

## 8.36 – Unattended Children in Motor Vehicles.

- A. It shall be unlawful and declared to be a nuisance by a person sixteen (16) years of age or older having the care or custody of any child under the age of ten (10) years to cause, permit or allow any child under the age of ten (10) years to remain in a motor vehicle while unattended or unaccompanied in that motor vehicle by a person sixteen (16) years or older.
- B. "Unattended" means either: (i) not accompanied by a person 16 years of age or older; or (ii) if accompanied by a person 16 years of age or older, out of sight of that person.
- C. In addition to all other remedies, any person who violates, disobeys, omits, neglects or refuses to comply with any provision of this Chapter shall, upon conviction, be subject to a fine not exceeding seven hundred fifty dollars (\$750.00). A separate offense shall be deemed committed upon each day during which a violation occurs or continues.

SECTION 3. AMENDMENT. Title 8 ("Health and Safety") of the Village of Harwood Heights Code of Ordinances, shall be, and hereby is amended to add Chapter 8.40 ("Confining Animals in Motor Vehicle") as follows: (additions in **bold and underline**):

## 8.40 - Confining Animals in Motor Vehicle.

- A. It shall be unlawful and declared a nuisance for any person to confine an animal in a motor vehicle in such a manner that places it in a life or health threatening situation by exposure to a prolonged period of extreme heat or cold, without proper ventilation or other protection from such heat or cold.
- B. It shall be presumed that an animal's health, safety, or welfare is endangered when the animal is confined in a parked or standing vehicle for a period of five (5) or more minutes when the ambient outside air temperature measures above seventy-five (75) degrees Fahrenheit or below thirty-five (35) degrees Fahrenheit.
- C. In order to protect the health and safety of an animal, an animal control officer or law enforcement officer who has probable cause to believe that this Chapter is being violated shall have authority to enter such motor vehicle by any reasonable means under the circumstances after making a reasonable effort to locate the owner or other person responsible.
- D. In addition to all other remedies, any person who violates, disobeys, omits, neglects or refuses to comply with any provision of this Chapter shall, upon conviction, be subject to a fine not exceeding seven hundred fifty dollars (\$750.00). A separate offense shall be deemed committed upon each day during which a violation occurs or continues.
- <u>SECTION 4.</u> <u>RESOLUTION OF CONFLICTS.</u> All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.
- <u>SECTION 5.</u> <u>SAVING CLAUSE</u>. If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.
- **SECTION 6. EFFECTIVE DATE.** This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form in the manner provided by law.
