ORDINANCE NO. 24-14

**AN ORDINANCE LEVYING TAXES FOR THE GENERAL CORPORATE
AND OTHER PURPOSES FOR THE FISCAL YEAR BEGINNING
MAY 1, 2024 AND ENDING APRIL 30, 2025
FOR THE VILLAGE OF HARWOOD HEIGHTS, COOK COUNTY, ILLINOIS**

WHEREAS, the President and Board of Trustees of the Village of Harwood Heights, Cook County, Illinois, did on April 25, 2024, pass and adopt the annual Appropriation Ordinance for the Village of Harwood Heights, Illinois (hereinafter "Village") for the fiscal year of the Village beginning on the 1st day of May, 2024, and ending on the 30th day of April, 2025, being Ordinance 24-05.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HARWOOD HEIGHTS, IN THE EXERCISE OF THEIR HOME RULE POWERS, AS FOLLOWS:

SECTION 1. Recital Incorporated. The foregoing recitals are incorporated into this Section 1 as though fully set forth herein.

SECTION 2. Tax Levy. Taxes are hereby levied upon all taxable property within the Village of Harwood Heights for the fiscal year ending April 30, 2025, for the following specific purposes:

SECTION 4. Unexpired Appropriations. All unexpired appropriations for the fiscal year ending April 30, 2024, are continued for the purpose for which they were appropriated and levied.

SECTION 5. Assessment of Tax Levy. The total amount of Two Million Forty Nine Thousand Eight Hundred Sixty Seven and 00/100 Dollars (\$2,049,867.00), exclusive of bond principal and interest, ascertained above, is hereby levied and assessed on all property subject to taxation within the Village according to the value of said property as assessed and equalized for the current year.

SECTION 6. Certification to County Clerk. There is hereby certified to the County Clerk of Cook County, Illinois, the several sums above, constituting said total amount, in the total amount of Two Million Forty Nine Thousand Eight Hundred Sixty Seven and 00/100 Dollars (\$2,049,867.00) which total amount the Village requires to be raised by taxation for the current fiscal year of the Village, and the Village Clerk of the Village is hereby ordered and directed to file with the County Clerk of Cook County on or before the last Tuesday of December 2024 a certified copy of this Ordinance.

SECTION 7. Severability and Repeal of Inconsistent Ordinances. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance, and all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.


SECTION 8. Effective Date. This ordinance shall be in full force and effect immediately after its passage and publication as required by law.

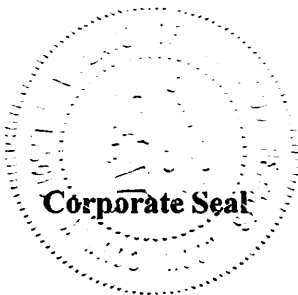


