ORDINANCE NO. 20-14

AN ORDINANCE AMENDING TITLE 17 OF THE VILLAGE OF HARWOOD HEIGHTS CODE OF ORDINANCES TO ESTABLISH LICENSING CATEGORIES FOR TOBACCO AND ALTERNATIVE NICOTINE PRODUCTS DEALERS AND LIMIT THE NUMBER OF LICENSES

WHEREAS, the Village of Harwood Heights (the "Village") is an Illinois municipal corporation organized and operating pursuant to authority granted by the Constitution and Laws of the State of Illinois;

WHEREAS, the Village is a home rule unit of government pursuant to Section 6(a), Article VII of the 1970 Illinois Constitution;

WHEREAS, pursuant to its home rule power, the Village may exercise any power and perform any function relating to its government and affairs;

WHEREAS, the Village regulates the retail sale and purchase of tobacco products and alternative nicotine products and electronic cigarettes pursuant to Title 4, Chapter 4.28, Article 26 of the Village Code;

WHEREAS, the Village Board is desirous of limiting the proliferation of tobacco and alternative nicotine product specialty stores within the community in order to enhance the public health, safety and welfare; and

WHEREAS, the Village Board has determined that it will serve and advance the public's health, safety and welfare and be in the best interest of the Village and its residents, to amend the Village Code to distinguish between tobacco-centric retailers that specialize in the retail sale of tobacco and alternative nicotine products as a principal use and commercial retailers that

incidentally sell such products;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Harwood Heights, County of Cook, Illinois, in the exercise of the Village's home rule powers, that the Village Code be amended as follows, with all existing provisions of the Village Code not set forth below continuing in full effect as currently written:

SECTION 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1. The findings and recitals herein are declared to be prima facie evidence of the law of the Village and shall be received in evidence as provided by the Illinois Compiled Statutes and the courts of the State of Illinois.

SECTION 2. Amendment to Licensee Fee Schedule. Title 4 ("Business Licenses and Regulations"), Chapter 4.08 ("Business License Fee Schedule"), Section 4.08.010 ("Schedule of Fees") of the Harwood Heights Village Code of Ordinances, shall be, and hereby is, amended as follows (additions underlined in bold font, deletions marked with strikethrough):

4.08.010 - Schedule of fees.

SECTION 3. Amendments to Title 4, Chapter 4.28, Article 26. Title 4 ("Business Licenses and Regulations"), Chapter 4.28 ("Other Businesses"), Article 26 ("Tobacco and Alternative Nicotine Products Dealers") of the Harwood Heights Village Code of Ordinances, shall be, and hereby is, amended as follows (additions underlined in bold font, deletions marked with strikethrough). Any Section or subsection omitted herefrom shall continue in full force and effect:

4.28.1260 - Definitions.

For the purposes of this article, the following words and phrases shall have the meanings respectively ascribed to them:

"Tobacco Shop" means a retail establishment principally engaged in the retail sale or display of Tobacco, Tobacco Products, Alternative nicotine products, Electronic cigarettes, Vape or Vaping products including, without limitation, vapes, vaporizers, vape pens, vapor cigarettes and alternative vapor transmission modalities and paraphernalia associated with any of the foregoing insofar as it either (i) devotes ten percent or more of floor area or display area to or (ii) derives more than sixty percent of its gross revenue from the sale of Tobacco, Tobacco Products, Alternative nicotine products, Electronic cigarettes, Vape or Vaping products including, without limitation, vapes, vaporizers, vape pens, vapor cigarettes and alternative vapor transmission modalities and paraphernalia associated with any of the foregoing. The term "Tobacco Shop" shall also include smoking lounges, which are retail establishments dedicated in whole or in part to entertaining smokers and users of tobacco. The term "Tobacco Shop" does not include Cannabis Business Establishments. "Tobacco Shop" also does not include establishments that incidentally sell or display such products as an accessory use, subordinate in purpose to the principal use served, such as a larger commercial establishment that incidentally includes a tobacco department or display incidental to the principal use of the premises.

4.28.1275 - Tobacco Dealer's License Classifications.

Licenses required in this Article 26 shall be and are divided into two (2) classes:

- Α. <u>Class A (Incidental Sales)</u> Tobacco Dealer's License – Required in order to engage in the retail sale or display of Tobacco, Tobacco Products, Alternative nicotine products, Electronic cigarettes, Vape or Vaping products including, without limitation, vapes, vaporizers, vape pens, vapor cigarettes and alternative vapor transmission modalities and paraphernalia associated with any of the foregoing where such sales or displays are incidental to the principal use of the premises, such as a tobacco department or display in a larger commercial establishment, such as a grocery store or convenience store which devotes less than ten percent of its floor or display area to such products and which derives less than sixty percent of its gross revenue from the sale of Tobacco, Tobacco Products, Alternative nicotine products, Electronic cigarettes, Vape or Vaping products including, without limitation, vapes, vaporizers, vape pens, vapor cigarettes and alternative vapor transmission modalities and paraphernalia associated with any of the foregoing.
- B. <u>Class B (Tobacco Shop) Tobacco Dealer's License Required in order to operate a Tobacco Shop as defined in Section 4.28.1260.</u>

4.28.1290 - License fees.

The license fee \underline{s} for a <u>Class A and Class B</u> to bacco dealer's license shall be as set forth in Section 4.08.010(13) of this code.

4.28.1295. Number of Licenses.

- A. There shall be an unlimited number of Class A (Incidental Sales) Tobacco

 Dealer's Licenses that may be issued and outstanding at any one time within
 the Village of Harwood Heights.
- B. There shall be no more than three (3) Class B (Tobacco Shop) Tobacco

 Dealer's Licenses outstanding at any one time in the Village. In the event that

 a Class B (Tobacco Shop) Tobacco Dealer's License is lapsed or revoked or

 the licensed premises becomes vacant for a continuous period of at least 90

 days, then the maximum number of Class B licenses in the Village shall be
 automatically reduced by one.

SECTION 4. RESOLUTION OF CONFLICTS.

All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5. SAVING CLAUSE.

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

SECTION 6. EFFECTIVE DATE.

This Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
